## Recognition Order

WHEREAS in terms of Section 14(1)/Section 15(1) of the NCTE Act, 1993 NINAIDEVI SHIKSHAN PRASARK MANDAL, SHIVAJIRAO DESHMUKH ADHYAPAK VIDYALAYA, PLOT NO. 1468, A/P SHIRALA, TAL-SHIRALA, DIST-SANGLI MAHARASHTRA (name of the Institution/Society) has submitted an application (Code No. APW05348/1221450) to the Western Regional Committee of NCTE for grant of recognition/permission for starting D.ED. (MARATHI) (CO-ED) course of Two year duration with an annual intake of 50 (Fifty) (ELEMENTARY) students.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to NINAIDEVI SHIKSHAN PRASARK MANDAL, SHIVAJIRAO DESHMUKH ADHYAPAK VIDYALAYA, PLOT NO. 1468, A/P SHIRALA, TAL-SHIRALA, DIST-SANGLI MAHARASHTRA (Name of the Institution/Society) for conducting D.ED. (MARATHI) (CO-ED) course of Two year duration with an annual intake of 50 (Fifty) (ELEMENTARY) students under clause 7(8) of Regulation dated 27-11-2007 (if applicable) subject to fulfillment of the following:

- I The institution shall, within one month of the receipt of recognition order, convey the endowment fund account into a joint account to be operated along with an official of the Western Regional Committee.
- II The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.


